Position Summary

The Keres Children's Learning Center (KCLC) seeks a **School Maintenance Worker** to make electrical, carpentry, plumbing, mechanical and related repairs and installations. This person will report to the Educational Director and Administrator. Position is part-time, exempt.

General Maintenance Duties and Responsibilities

- Identify needed repairs and maintenance
- Provide repairs and maintenance for KCLC buildings and landscaping as needed or work with outside contractor to oversee repairs and maintenance
- Safely operate standard tools and equipment of the trade
- Clean and maintain tools and equipment
- Operate light and medium motor equipment
- Operate motor vehicles as assigned

Qualifications:

- High School diploma
- Ability to pass a background check

Physical Requirements:

While performing the duties of this job, the employee is frequently required to stand, walk use hands and fingers to handle, or feel objects, tools, or controls; and talk or hear. The employee frequently is required to reach with hands and arms such as to operate vibrating machinery. The employee is occasionally required to sit, frequently must squat, stoop or kneel, reach above the head and reach forward. The employee continuously uses hand strength to grasp tools and climbs on to ladders. The employee will frequently bend or twist at the neck and trunk more than the average person while performing the duties of this job. The employee must frequently lift and/or move up to 50 pounds or more. The employee will sometimes push/pull items such as tables, scaffolds, and cabinets. The employee regularly works indoors and will occasionally work outdoors. Specific vision abilities required by this job include close vision, color vision, peripheral vision, depth perception, and the ability to adjust focus.

- Be a self-starter; manage time appropriately
- Operate safely at all times
- Work collaboratively and independently
- Abide by KCLC Policies and Procedures
- Speak Keres language as much as possible while on school grounds
- Have a valid driver's license and vehicle
- Undergo background check

- Take initiative to serve KCLC's mission
- Obtain approval for equipment or supply purchases
